Major Violations

Parents will be called to pick up their child for the following – but not limited to:

7. Leaving the premises or being in unsupervised areas
8. No Electronic devices, CD's, Tapes, Cell phones, Cameras, Computer games or Skateboards are to be brought to the Life Center. Confiscated items will be released to parents.
